### Introduction

Securitas Security Services (UK) Ltd are proud of the steps we take to ensure that we do not associate with organisations, or employ individuals, who are linked to slavery or human trafficking. The correct level of due diligence is taken to ensure our suppliers operate in ethical ways within the parameters of the law in the UK.

Furthermore, Securitas Security Services (UK) Ltd undertake a stringent screening process when employing all employees to ensure our suppliers are acting ethically when sourcing candidates.

## **Structure**

Securitas Security Services (UK) Ltd are the provider of Protective Services based on people, technology and knowledge. Securitas Security Services (UK) Ltd operate on an international level, with our group employing over 360,000 employees worldwide.

#### **Our Business**

Our business is split into seven geographic areas within the UK, that comprise of a number of smaller individual business units delivering bespoke protective security solutions to small and medium sized local businesses. To support these business units Securitas Security Services (UK) Ltd also has dedicated areas to support larger UK and Global Customers dedicated to specific market sectors; such as logistics, pharmaceuticals, finance and information technology.

## **Our Supply Chains**

Our supply chains include outsourcing of IT services, fleet management, uniform and stationary supply. Our supply chain is based within the UK, however some of the products and services supplied to Securitas Security Services (UK) Ltd may have originated offshore.

## **Due Diligence Process for Slavery and Human Trafficking**

- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

## **Supplier Adherence to our Values and Ethics**

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values & ethics we have in place an internal annual rollout of our values and ethics policy to all employees to ensure they are aware of the company's position in relation to human trafficking and slavery. The delivery of this material is administered by our HR department.

## **Training**

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide training to our staff. Regular training on values and ethics is provided to all employees and new starters within 3 months of them commencing employment.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our slavery and human trafficking statement for the financial year ending 31st December 2020 and was approved by the Board of Directors of Securitas Security Services (UK) Ltd on 8th April 2019.
