This Policy Statement is issued by Securitas Services Holding (UK) Limited and is applicable to all its subsidiary companies and employees. Securitas recognises environmental protection as one of the guiding principles of, and a key component to sound business performance. Securitas will provide a quality service in a manner that ensures the organisation minimises its potential impact on the environment. Operating in compliance with all relevant environmental legislation, Securitas is committed to achieving the continual improvement of its Environmental Management System, the protection of the environment and pollution prevention, with action taken towards developing climate change mitigation and sustainable resource utilisation through environmental best practice in all aspects of its business.

To achieve these objectives Securitas will:

- Control and manage its activities to ensure that adverse effects on the environment will be minimised as far as is practicable.
- Consider environmental factors and their impact in our planning, decision making and execution of operational activities throughout the Company, including the environmental impact when relocating or expanding existing facilities.
- Minimise waste through promoting the reduction, re-use and recycling of waste stream resources where practicable, available, economical and suitable for their relevant purpose.
- Working towards a Net Zero goal, with an initial 42% reduction in emissions by 2030, set through our Science Based Targets Initiative commitment.
- Continue annual carbon emissions monitoring against Scopes 1, 2 & 3 to establish the organisation's key
 activities and impacts, setting these against a carbon reduction programme that includes the use of
 alternative energy and low energy resources wherever practicable.
- Promote environmental awareness among all managers, staff and employees and proactively encourage them to work in an environmentally responsible manner by communicating this policy.
- As part of our procurement process, encourage the selection of environmentally friendly products/services and favourably consider suppliers who demonstrate a higher level of environmental management.
- Promote the efficient use of materials and resources throughout the company, including water, electricity, raw materials and other resources, particularly where such materials are non-renewable.
- Ensure compliance to the Securitas Group Environmental Policy, especially the sustained reduction of emissions values from fleet activities of company operated owned and leased vehicles, business travel and energy consumption.
- As required by legislation or where significant environmental concerns exist, maintain adequate and
 appropriate procedures to ensure the necessary control requirements, including inspections are adopted as
 far as is reasonably practicable and reporting of environmental incidents is undertaken appropriately with
 investigations conducted to root cause.
- Communicate our environmental policy to both potential and existing clients, suppliers, contractors and
 employees encouraging them to support this policy and co-operate with our clients' established
 environmental protection processes wherever such management systems are in practice on their sites. This
 policy is made available to the public upon request or via the Company's Internet.

An annual review to this Environmental Policy will be undertaken in accordance with the Group Environmental Policy, Securitas UK's ISO 14001:2015 standard and other sustainability related audit results, objectives, targets and its arrangements as defined within the organisations environmental management system, Aspects & Impacts Register and EH&S Plan.
